READY, SET...RIDE! SOUTHEAST LIGHT RAIL SET TO OPEN NOVEMBER 17th!



The highly anticipated Southeast extension of the light rail system is scheduled to begin operations on Friday, November 17th with free rides all day.

The Southeast Light Rail system offers commuters four new train lines covering 19 miles of service as well as 11 new bus routes and 10 new call-n-Ride areas (see call-n-Ride article inside).

Except for the Louisiana / Pearl station, all of the new stations will provide free parking for customers, although parking congestion is expected. Commuters are

encouraged to use local buses or the call-n-Ride service whenever possible or have someone drop you off at the station.

CHANGES COMING FOR COMMUTERS

The opening of the Southeast light rail and expanded bus system will bring significant changes to many commuters. Many Express and Regional bus routes in the southeast area are being discontinued and replaced by local bus routes that connect to the new light rail stations or by the call-n-Ride system. COMMISSIONED ARTWORK

Along with unobstructed views of the entire Front Range, light rail commuters will enjoy commissioned artwork dis-

played at every station, each with a specific theme. The theme for the County Line Station is 'Countryside'.

The Dry Creek Station's theme is 'Flowing Stream'. Both themes are visible in the specially designed windscreen benches and station handrails.



can be made between bus, light rail and call-n-Ride services. Your final destination will determine if an additional fare is required.

NORTH INVERNESS call-n-Ride: 303-994-9885. Service area boundaries are Arapahoe Road on the North, Lima Street on the East, County Line Road on the South and 1-25 on the West. Service area also includes the Drv Creek Light Rail

SOUTH INVERNESS call-n-Ride:

Station.

303-961-5109. Service boundaries are County Line Road on the North, Peoria Street on the East, E-470 on the South and I-25 on the West. Service area also includes the County Line Light Rail Station.

At the request of the Inverness Metropolitan District, RTD has agreed to allow the two Inverness areas to overlap slightly during peak times so that the South Inverness call-n-Ride will extend north to the Inverness Hotel and Conference Center, in addition to several other buildings in that area. Contact the call-n-Ride driver for more information.

During off-peak hours (8:30 am-3 pm) and (6 pm-8:00 pm), North and South Inverness will be combined forming one call-n-Ride service area. Call-n-Ride will operate from the West side of the Dry Creek Light Rail Station until the completion of the pedestrian bridge. Call-n-Ride service at County Line Light Rail Station during off-peak hours is by reservation only. For service to and from Inverness Business Park, DO NOT use

the Dry Creek call-n-Ride as the Dry Creek call-n-Ride area does not include Inverness.

The call-n-Ride system is designed to be flexible during the start-up period with several contingency plans already prepared, ranging from shifting the number of buses in each area to creating permanent circular bus routes as needed in order to compensate for rider demand. RTD asks that users be patient as any initial problems with the system are worked out.

CALL-N-RIDE

What is it? Call-n-Ride is a curb-to-curb local transportation service that will take you anywhere you want to go within designated service areas. The service is available for transportation to work, school, shopping or to connect with RTD bus routes and the light rail.

How it Works. Call the appropriate number for your area at least one hour in advance. Pre-arranged, recurring trips may also be arranged on a subscription basis. Drivers will group trip requests creating shared trips whenever possible.


One-Way Local Cash Fares (exact change only): \$1.50 or 75¢ discounted fares for seniors 65+, individuals with disabilities, Medicare recipients and K-12th grade students, age 6-19. All RTD passes and tickets are accepted for the call-n-Ride.

Transfers Ask the driver for a transfer if you are connecting to another RTD service. Use your light rail ticket if you are transferring from the light rail. Transfers

With the opening of the Southeast Light Rail extension, the light rail system will be divided into four fare zones. Fares are determined by the number of zones in which a passenger travels for each one-way trip as illustrated in the table above. The vending machines where you will purchase tickets are programmed to automatically calculate the correct fare based on the selected destination. Additional fares will be required if monthly pass-holders travel beyond the zones listed on their pass.

The fixed-route busses do not run on the zone system. They will continue to either be labeled as local, express or regional busses, but the call-n-Ride busses are always a local fare. If a passenger is traveling within one or two zones on the light rail and plans to transfer to either a call-n-Ride or fixed-route local bus, the entire fare is \$1.50. When transferring from either light rail to a local bus or vice versa, passengers need to collect a transfer from either the driver or the ticket vending machine at the station.

When transferring from the light rail to an express or regional bus, the passenger will pay the difference in the fare to the bus driver. When transferring from a call-n-Ride to the light rail and the fare for the light rail is more than the local fare, the passenger needs to receive an upgrade from the ticket vending machine at the light rail station. Input the credit for the local fare and select the appropriate difference in the upgraded fare. If a fare inspector asks to see a passenger's ticket, they will need to show both the call-n-Ride transfer and the upgrade that was purchased at the sta-

THE INVERNESS CONNECTION

The Dry Creek Station is located south of Dry Creek Road and west of I-25. 236 park-n-Ride spaces have been allotted to RTD on the top level of Charles Schwab's parking garage. From eastbound Dry Creek, a right turn lane allows access into the park-n-Ride. The drop-off point for commuters and call-n-Ride users is off of Panorama Circle (turn east from Chester). A pedestrian bridge allowing direct access to Inverness will be completed. Until then there will be no access to the station from the east side of 1-25 and no parking available. The North Inverness call-n-Ride services this station.

The County Line Station is located on the west side of I-25. The station's park-n-Ride is on the east side of I-25 south of County Line Road, east of I-25 and accessible from South Valley Highway. The park-n-Ride will hold 388 cars. Please note that for the time being there is no access from the station to Park Meadows Mall. The South Inverness call-n-Ride services this station.
